ADAPTING OUR SERVICES TO PURSUE OUR MISSION TO PROTECT CHILDREN ACROSS LEBANON:

In spite of all the challenges and turmoil carried out by the Lebanese economic crisis and worldwide pandemic, we were still eager to carry out our mission and maintain our operations.

Prevention activities were readapted to the context (FPSS, CBPSS, training, awareness sessions in schools) to the online and remote modality, while our response to cases along with referrals also pertained to face-to-face modality and remained effective. The context forced us to shift away from the face to face learning modalities and to dive into alternative models of learning and training with 47% of our training sessions delivered online in 2021.

Despite all challenges and although not part of our mandate, our team at the **Ministry of Justice** was still able to visit the Justice Palace and be physically present in accordance with public safety measures, for preliminary investigations conducted with children, and to register the needed rulings, avoiding delays and interruptions in the protection of children.

To optimize the protection of our front-liners and the entirety of the team members, a vaccination drive was implemented, enabling us to continue providing quality services throughout the year, and with lower risks. Our judicial procedure was adjusted to prioritize the best interest of the child at all times. In cases of excessive violence against children, we were able to immediately involve the General Prosecutor and remove the imminent danger in less than 24 hours. Our team would start the evaluation process in order for the general prosecutor to take appropriate actions before transferring the case to the juvenile judge. This procedure positively affected the coordination between General Prosecutors and Juvenile Judges and was in favor of the best interest of every child in need.

Throughout 2021 himaya tackled the alarmingly increasing number of abandoned children's cases that were caused by the economic crisis. Our intervention in cooperation with juvenile judges was crucial to the placement of these children in foster families or with other members of their extended families, through family-based **alternative care** protocols.

With multiple institutions that were forced to shut down, we had to immediately respond to the urgent demand by enabling the families to become the source of protection for their children. After a thorough assessment and when possible, himaya reunited children with their families to avoid separation and maltreatment, all while offering support to these families on all fronts.

STRENGTHENING THE CHILD PROTECTION NETWORK THROUGH IT ALL

As a way to strengthen local communities and empower their role when it comes to child protection practices, himaya was still able to establish sustainable and strategic partnerships with key-community actors despite all challenges:

INTERNAL SECURITY FORCES ACADEMY (ISF)

As part of an ongoing collaboration with the Internal Security Forces Academy (ISF) himaya continued to provide training sessions for ISF members about child-friendly investigation techniques. This training is part of a longer training program provided by the ISF to officers with the objective of giving participants information about how to investigate with children (child development, child protection principles) and to help them practice techniques that are specific to investigations with children.

This year and due to the financial crisis, these sessions were conducted at their respective districts instead of being centralized in Beirut. This action proved to be very fruitful since it helped cut transportation costs and made us understand the specificities and challenges of every area.

TRIPOLI BAR'S ASSOCIATION - NORTH LEBANON

himaya in partnership with <u>UNICEF Lebanon</u>, delivered a child protection training to **35 lawyers** from the Tripoli Bar's Association as a way to reinforce the linkages and remind them of their role when it comes to child protection.



ADAPTABILITY



<u>HUMANITY</u> <u>& INCLUSION (HI)</u>

himaya in partnership with <u>UNICEF Lebanon</u>, addressed a training to Humanity and Inclusion, Fista and their local partner's team, on safe identification and referral of cases of Children with Disabilities. This allows us to mainstream Child Protection notions in other sectors such as Shelters, Education and Health. We reached **33 participants.**

In return, HI provided himaya with training sessions around the topics of inclusion, accessibility communication and other key elements of working with children with disabilities. Our regional office in Beirut/Mount Lebanon was also able to implement all those notions and adapt the rest-rooms in a way to be more inclusive and accessible.

Moreover, several departments, including HR or the prevention team benefited from this partnership to adapt our services and our procedures to become as inclusive as possible.

In addition to the above, himaya distributed **250 Educational kits** as well as **20 tablets** to children with disabilities.

MUNICIPAL POLICE & GENERAL SECURITY (G S)

In partnership with Save the Children Lebanon and as part of an ongoing collaboration with the General Security, himaya continued to provide training sessions for General Security members.

In collaboration with UNICEF, **92 MP Officers** (MP) were trained on child protection across Lebanon. In partnership with Relief International and funded by RDPP, we have also worked on reducing Child Labor amongst vulnerable populations in North Lebanon. Therefore, MP Officers were trained on identifying and enforcing child labor violations and proper handling of cases. 3 municipalities were also engaged in creating plans to support working children.

SCHOOLS & INSTITUTIONS

19 TOTAL SCHOOLS under the World Vision project

himaya has developed, in collaboration with UNRWA, a manual guide for the school counselors on how to properly handle situations of children showing signs of abuse in school settings: Safe identification & referral and child friendly communication guidelines.

In collaboration with World Vision, himaya's CBRD (Capacity Building & Research and Development) department also worked with **5 new schools** on developing and implementing child protection policies. Training reached **72 school staff.**



SYNDICATE OF SOCIAL WORKERS

In 2021, himaya trained the Syndicate of Social Workers on the Family-Based Alternative care response amidst the Covid-19 pandemic. We reached **46 Social Workers** from across Lebanon.



MEDICAL PERSONNEL

In 2021, 3 online presentations were addressed to medical staff *(Doctors, Pharmacists, Red Cross members)* on how to properly handle situations of children showing signs of abuse in a medical setting.

WIDENING OUR SCOPE OF INTERVENTION TO BETTER SERVE OUR COMMUNITY:

Lebanon's economic and health crisis has severely affected our beneficiaries, and has increased the vulnerability factors of the entire community. In order to respond to the emerging needs, himaya expanded its services amid the economic hardship, to include **social assistance services** that would serve children and families with protection needs in the regions of Beirut, Mount Lebanon and North Lebanon.

We were also able to refer our beneficiaires to UNICEF's **'Haddi'** program which is Lebanon's national child grant. Haddi provides monthly cash grants linked to basic services to households with vulnerable children and youth. It is implemented in collaboration with the Ministry of Social Affairs and with the support of over 40 partners in communities across all Lebanon's 8 Governorates. All children who have been identified by UNICEF programs as in need of priority services are referred to Haddi. These include protection services for children at risk of child labour or child marriage, non-formal education for children excluded from school, children with disabilities, as well as nutrition services.

In response to the needs identified among parents and caregivers, himaya's Resilience Program engaged in a **new evidence-based tailored program** that consists of group intervention with caregivers for the purpose of enhancing their parental styles and in consequence decreasing the risk of resorting to abuse and violent discipline with children.

LGBTQ+ TRAINING FOR ALL RESILIENCE STAFF + THE JUDICIAL PROTECTION TEAM

In the perspective of enhancing our intervention approach, himaya's Resilience program also benefited from an advanced training provided by "HELEM " on how to deal and qualitatively intervene with children & adolescent who are tormented with **sexual orientation** and face abuse in the journey of defining their orientation.

Due to perpetual changes on a national level and the emerging stress, front-liners have been doing their best to cope with the situation and protect themselves from professional burn-out. As part of our **staff care policy,** himaya reinforced capacity building and self-care practices among the team including monthly regional Supervision sessions. The aim of staff care practices is to ensure a safe space for team members to overcome technical difficulties and release professional pressure.

WIDENING OUR SCOPE OF INTERVENTION TO BETTER SERVE OUR COMMUNITY:

HIMAYA OFFICIALLY MANDATED TO COVER THE BEKAA REGION

Himaya was mandated during 2021 by the Ministry of Justice to work with Juvenile Courts in the Bekaa Governorate in addition to its existing mandate to cover the North Governorate. This mandate includes the cases of children in danger and it covers **Central and West Bekaa, Zahle, Baalbak and Hermel.**

Our contract with the **Ministry of Justice expanded to the Bekaa region**, and we were able to widen our reach to the North and Bekaa regions by being present with the child from the stage of preliminary investigation, until the closure of the case by the juvenile judge. On another hand, our partnership with the Bar Association in Tripoli, also enabled us to secure representation of atrisk children when there is legal action against offenders.

In 2021, himaya partnered up with **Qarama**, a local organization mandated by the Ministry of Justice that works with children in danger and children in contact with the law covering the Mount Lebanon area. Moreover, himaya has been conducting a series of capacity-building training sessions with multiple sessions still lined up to happen throughout 2022. Himaya organized a series of training sessions spanning over a few months to build the capacity of Qarama's team. These sessions tackled a wide variety of topics that constitute crucial knowledge to the team in their capacity as juvenile justice workers with the juvenile judges in Mount Lebanon such as communication with children, role of the social worker alongside the child during preliminary investigations, Standard Operational Procedures (SOP), Juvenile Justice, Judicial Pathway and Legal Procedures.

STARTING THE NEEDED **CONVERSATIONS IN BAHRAIN!**

himaya also started developing a social workers guide to the judicial pathway and the roles of different stakeholders involved. Moreover, and to celebrate World Children's Day in March 2021, an innovative **online webinar** was launched across our online channels, titled: "Strengthening the child protection network within the community".

himaya was a guest speaker and attended the World Congress on Justice with Children in the MENA workshop titled "Fostering the Reintegration of Children in Conflict with the Law and Enhancing the Protection of Children in Contact with the Law: Field Experiences from Lebanon".

HIMAYA LANDED

In partnership with BEACON Private School in Bahrain, himaya has been working hand-inhand with the school staff on developing and implementing their child protection policy. This allows schools to have internal regulations and procedures to help them fulfill their responsibilities regarding Child Protection.

Implementation includes developing a policy document on Child Protection as well as training child protection focal points and school staff on Child Protection notions. Training reached 65 school staff.

the prevention program also intervened with 200 students by providing them with remote awareness sessions on the 4 types of abuse, internet safety and bullying. The aim of this intervention was to provide them with self-protection skills to disclose any type of violence to an adult they trust.

The sessions were provided through zoom, where the facilitator in Lebanon was behind a screen and in front of students in class. Several interactive techniques were used to provide these sessions and make them as interactive as possible.

Children expressed that they were satisfied and happy about these sessions as they were learning new key messages while having fun.

OUR FLUFFLY COLLABORATION: "DARDACATS"



DARDACATS IS A PLUSH PUPPET WITH A SOCIAL **MISSION!**

We see it as an empowering tool for children to discover and express themselves freely, while enhancing their emotional and social skills. Roleplaying encourages children to share difficult feelings and promotes their development on an educational, intellectual, and cognitive level.

IT COMBINES THE LEARNING AND DEVELOPMENTAL BENEFITS OF BOTH A PLUSH TOY AND A PUPPET: SPEECH & LISTENING SKILLS, SOCIAL & EMOTIONAL SKILLS, IMAGINATIVE PLAY.

The Story of Sarah and her magical (Darda) Cat "Baskoot"

Sarah, a seven-year-old girl, was living with her paternal grandparents and father following her parents' divorce.

The parents divorced three years ago, and Sarah hasn't seen or spoken to her mother in two years. The mother filed a complaint with the appropriate court and requested to see Sarah, and the spiritual judge ordered Sarah to live with her mother at the home of her maternal grandparents.

Sarah attended three sessions silently; she was present but said nothing using words. She appeared anxious and avoided eye contact, her gaze falling on the floor and occasionally on the room's games.

We noticed that she kept her gaze on the Dardacat throughout these three sessions. When we asked if she wanted to play with it, she smiled and that's how Dardacats became the starting point for developing a professional relationship with the child allowing the latter to express her emotions, desires, thoughts, expectations, and fears.

Her fears were mainly centered on the relocation to her mother's house, a mother she hadn't seen, met, or heard from in a long time.



With the support of the Dardacat, the child's ability, and the professionals at himaya, the child was able to comprehend and accept her parents' separation, express her feeling of guilt, and express her fears of not being accepted by her mother and new entourage. She expressed her happiness at the prospect of meeting her mother but also voiced her fear at the prospect of being put in an unfamiliar situation.

We tried to prepare for this new placement using Dardarcat to the extent that the circumstances and resources permitted it Sarah named her CAT "BASKOOT" who helped her name her feelings and put her thoughts, fears, and emotions into words during the session.



She refers to BASKOOT as her friend, a confidante one with whom she can share secrets and feel accepted and loved. She always embraces her cat, as if she were giving love to her.

"BASKOOT is my best friend," Sarah stated. "I want her to be with me." and she chose to bring the cat back to her mother's home.

We met with the mother and encouraged her to seek out this enchanted cat, while also explaining the cat's significance and role. The mother was happy because she wanted to spend time with her daughter and nurture their relationship.

"BASKOOT" helped the mother and daughter in building and developing their relationship. Additionally, the mother used BASKOOT to establish the house-rules in a playful and nonthreatening way.

"BASKOOT" played an important role in fostering more natural and efficient mother-daughter interaction and communication. We were also able to observe that the cat represented the protective image of "HIMAYA," the symbol of protection, security, and comfort for Sarah.

This year, himaya's prevention team made it its mission to develop three board games that give vulnerable children an opportunity to learn about their rights, protection, safety, life skills, and more:

HOW'S WORK? A game that teaches children about child labor, safety, and protection at work. In partnership with PLAN International.



IF YOU HAD THE CHOICE... A game that teaches children important life skills, to help them make better decisions in their lives.

Inclusion was a key factor in designing the games, allowing every single child to relate to the characters, no matter their age, size, gender, appearance, color, or disability.

The board games have also been adapted to life-size versions and are being used as tools in the safe parks, so children could make the best out of playing and learning.

MORE CHILD-FRIENDLY SPACES ACROSS LEBANON:

In September 2021 and as part of our "safe parks" project, we opened two newly renovated parks in Beirut; one in Kaskas and the other in Karm El Aris.

Both communities were involved in the design process of the renovation, using a participatory approach to nurture ownership and continuity of the project.

A COMMUNITY-BASED APPROACH TO ADDRESS CHILD LABOR IN LEBANON



Due to the difficult economic conditions, some parents may have to push their children into the labor market at an early age, which is what we are currently witnessing in Lebanon.

However, the fundamental principle remains that the child has no place in the labor market.

Parents, employers, and local authorities have a shared responsibility to ensure that children are protected and their rights guaranteed in all circumstances.

Understand the reality of Child Labor in Lebanon led us to innovate our approach and intervene with the community as a whole.

INNOVATION

Capacity building activities with local Community-Based Organizations (CBOs)on facilitation skills, child protection, and the referral pathway of cases of abuse. This community-based approach allowed the CBO's staff to become equipped with the needed skills to organize awareness sessions on their own and implement community-based psychosocial activities within their respective communities.

A workshop tackling the Worst Forms of Child Labor was conducted by himaya and was addressed to employers from North Lebanon. Small business owners joined the workshop to learn more about the physical and psychological consequences of labor on working children, and to get informed about the childlabor law and their role in addressing the issue. The aim of the workshop was to raise awareness and to reduce the risk of child labor and abuse.

By the end of the workshop, the employers pledged to act as a referral gate of cases of child abuse, and join the fight against child labor.

In parallel, himaya, in partnership with Plan International and with funding support from the European Union, launched an advocacy campaign to protect working children and their families, and to activate the national action plan for eliminating child labor in Lebanon.





The campaign aimed to highlight the worst forms of child labor (WFCL) particularly in the Lebanese agricultural sector, and to educate parents and employers together on how to protect children from the psychological and physical risks involved, while ensuring that their rights are being met.

The campaign's main hashtag was: #رجعولي_طفولتي and reached more than 2 Million as per the <u>WFCL Campaign</u> <u>presentation.</u>

In December 2021, and as part of our effort to ensure the sustainability of our services within communities, himaya's prevention team hosted an event: Volunteers in Action for Child Protection to celebrate the **International Day of Volunteers** and to recognize their efforts and contribution towards child protection.

The hall was filled with over 100 young volunteers who came from all around Lebanon to share their stories and celebrate their achievements. The event featured speeches and testimonials, a video about the volunteers' work, and team-building activities.

himaya's Executive Director, Serge Saad, addressed the volunteers with a heartfelt speech, thanking them for reaching over 29,000 children. After which, some volunteers shared their testimonials about their experience volunteering with himaya,

THE SELF-CARE CURRICULUM FINALLY IN ACTION

To say that parents are stressed and overwhelmed right now is an understatement. There's so much uncertainty. Many parents have lost their jobs or are facing the potential. Those who were working from home were doing so while also trying to teach their children simultaneously.

The list of stress factors is unlimited, and usually, <u>self-care</u> for parents often slips to the bottom of their priority list. But taking care of oneself isn't a luxury. It's essential. And during these difficult times, we thought it was more important than ever.

In response to the needs of caregivers, himaya's prevention program developed and finalized The Self Care addressed to caregivers and covering several topics such as getting to know our emotions, managing them, discovering one's strengths and points to improve, techniques for stress management and many more. The curriculum was applied both remotely as well as on the field to help parents fill a bucket of energy that will keep their relationship with their children healthy, without burning out.

THE POWER OF MUSIC

Music is a universal language that everyone can speak. When words fail, music helps to express love, anger, happiness, eliminate feelings of despair, change the mood, even heal a broken heart, and soothe a troubled soul.



Aware of the value of music, the team began integrating music into their activities. "Listen", a music curriculum for childraen, was developed by our talented facilitators and was implemented in himaya's approach to practice music therapy as a strong driver of improvement and growth among beneficiaries.

Staff and outreach volunteers across himaya's offices received training on how to use music as a tool to teach children about important topics, and encourage them to express themselves, innovate, and become better communicators.

A SUSTAINABLE APPROACH:

A BREAK FROM THE MUNDANE

PSS and educational kits were distributed to himaya's beneficiaries all across Lebanon. These kits aimed to bring a positive change in children's lives, break their routine while at home and give them a chance to express themselves, through fun and effective motor and cognitive activities to help them cope with stressful circumstances and engage positively with their family members and peers.

HIMAYA & OTHER COUNTRIES CROSS-BORDER CASE MANAGEMENT:



ISS partners on 14 cross-border cases (from Germany, UK, Australia, Canada, Switzerland and Ethiopia) and we were able to support 20 children (14 families) with welfare and kinship assessment and tracing.
